## ORDINANCE 2015-2

AN ORDINANCE ANNEXING CERTAIN REAL PROPERTY OWNED BY ROBERT L. KRAUSE, JR., INTO THE MUNICIPAL LIMITS OF THE TOWN OF ST. LUCIE VILLAGE, FLORIDA.

WHEREAS, Robert L. Krause, Jr., is the owner of a tract of land described in attached Exhibit "A", which property is in the unincorporated area of St. Lucie County but contiguous to the Town of St. Lucie Village, Florida and reasonably compact; and

WHEREAS, Robert L. Krause, Jr., has petitioned the Board of Aldermen to have the property annexed into the Town of St. Lucie Village, Florida and annexation would not create enclaves; and

WHEREAS, §171.044, <u>Fla. Stat.</u>, specifies the procedure for voluntary annexation of real property into a municipality; and

WHEREAS, the terms and provisions of \$171.044, <u>Fla. Stat.</u>, have been met, including publication of notice and providing a copy of this Ordinance, via certified mail return receipt requested, to the St. Lucie County Board of County Commissioners.

NOW, THEREFORE, the Board of Aldermen of the Town of St. Lucie Village, Florida hereby ordains:

- 1. The above described land, which is more particularly described in Exhibit "A" attached hereto and incorporated herein, is hereby added to, taken into, made a part of, and annexed into the municipal limits of the Town of St. Lucie Village, Florida, and the municipal limits thereby redefined to include said property, the correct legal description of which is encompassed in attached Exhibit "A". A map depicting said property is also attached as Exhibit "B". A complete legal description by metes and bounds is attached as Exhibit "C".
- 2. Said property is deemed to fall within the current R-1 residential zoning.
- 3. A copy of this Ordinance shall be filed with the Clerk of the Circuit Court of the St. Lucie County, the Chief Administrative Officer of St. Lucie County, and the Department of State within seven (7) days after adoption of the Ordinance.
  - 4. This Ordinance shall become effective upon passage.



## EXHIBIT "C"

Legal description by metes and bounds:

Property located in St. Lucie County, Florida, described as follows:

Beginning at a point on the Northeast corner of Lot 15, Block A, M.D. HUNT SUBDIVISION, as per plat thereof, recorded in Plat Book 9, page 47, of the Public Records of St. Lucie County, Florida; thence run South along the East boundary line of said Lot 15 to the Southeast corner of said Lot 15; thence turn on an angle of 90° and run East to the West right-of-way line of State Road 605; thence turn and run Northwesterly along the West right-of-way line of State Road 605 to a point of the intersection of said West right-of-way line and a line projected and extended due East of the North line of said Lot 15; thence turn due West and run along said extended line to the POINT OF BEGINNING.

Beginning at a point on the Northeast corner of Lot 15, Block A, M.D. HUNT SUBDIVISION, as per plat thereof, recorded in Plat Book 9, page 47, of the Public Records of St. Lucie County, Florida; thence run West along the North boundary of said Lot 15 to a point 40 feet West from the Northeast corner of Lot 15; thence run South approximately 129.11 feet to a point on the South boundary of said Lot 15 being 40 feet West of the Southeast corner of said lot; thence proceed East to the Southeast corner of said Lot 15; thence proceed North along the East boundary of said Lot 15 to the Northeast corner of the lot and the POINT OF BEGINNING.
