**Subject:** FW: Brightline - Crossing Construction Dates

Mary,

Below is a schedule for the Brightline contractor's work on railroad crossings in the vicinity of St. Lucie Village. I thought I had sent this out earlier, but apparently I did not. There will be a detour or bypass for each crossing to assure that Village residents will have access around the work zone 24 hours per day when the crossing is closed.

- For Rouse Road, they will have a 2-lane detour on railroad right-of-way immediately east of the tracks to the Michigan Street crossing, about a half mile to the north. The Michigan Street crossing will be fully operational while the Rouse Road crossing work is in progress.
- From what I have seen so far, the Torpey and Milton crossings will have a bypass constructed to cross the tracks near the crossing work. Since these temporary crossings will not have automated signals, flagmen will be present 24/7 when the bypass is being utilized.
- When working on the Chamberlin crossing, traffic will be detoured to the St. Lucie Lane crossing and visa versa.
- For work on the private Shimonek Lane crossing, there will be a local bypass. Shimonek is not on either of these lists, so I do not know the schedule for that one.

1. MP 263.10 Michigan Street – 11/10/2021 to 11/21/2021
2. MP 233.90 Private Road / Kennedy Groves – 11/21/2021 to 12/01/2021
3. MP 236.70 Rouse Road – 12/03/2021 to 12/14/2021
4. MP 253.07 Riverview Drive – 12/10/2021 to 12/19/2021
5. MP 238.41 Chamberlin Blvd – 12/13/2021 to 12/23/2021

**Month of January and February 2022** (subject to change)

6. MP 243.60 Midway Road – 01/03/2022 to 01/14/2022
7. MP 237.77 Milton Road – 01/07/2022 to 01/18/2022
8. MP 237.10 Torpey Road – 02/01/2022 to 02/10/2022
9. MP 238.80 St. Lucie Lane – 02/06/2022 to 02/17/2022
10. MP 241.79 Fisherman's Wharf – 02/11/2022 to 02/24/2022
11. MP 234.52 Harbor Branch Found – 02/18/2022 to 02/28/2022

We have made sure that no adjacent crossings will be closed simultaneously. As previously discussed, any crossing that has a temporary bypass in place during construction will have flaggers present 24/7 in order to keep the flow of traffic moving through the roadway. Dan will ensure that Road Closure Notices are distributed by the County 2 weeks prior to any construction, and VMS Boards will be placed on site by the applicant 2 weeks prior as well.
