

RESOLUTION 2023-4

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF ST. LUCIE VILLAGE REGARDING THE 2023 ELECTION AND APPOINTING A CANVASSING BOARD, ELECTING AN ELECTION BOARD, APPOINTING POLL WORKERS, AND OPTING OUT OF EARLY VOTING.

WHEREAS, there shall be an election on May 2, 2023, at which three members of the Board of Aldermen shall be up for election;

WHEREAS, pursuant to Florida Statutes, a Canvassing Board must be appointed;

WHEREAS, pursuant to Florida Statutes, an Election Board must be appointed;

WHEREAS, the Board of Aldermen find it to be in the best interest of the Town of St. Lucie Village not to participate in any early voting and pursuant to Florida Statutes the Board of Aldermen must communicate that decision to the St. Lucie County Supervisor of Elections.

NOW, THEREFORE, the Board of Aldermen of the Town of St. Lucie Village, Florida hereby resolves as follows:

1. The Board of Aldermen appoint, pursuant to Ordinance 97-1 of the Ordinances of the Town of St. Lucie Village, the Board of Aldermen of the Town of St. Lucie Village, Florida, Mary Fowler (Clerk), William Thiess (Mayor), and Gertrude Walker (St. Lucie County Supervisor of Elections) as the Canvassing Board for the 2023 election.

2. The Board of Aldermen appoint the following persons to the Election Board for the 2023 election:

- a. Linda K. Mongrain, Clerk
- b. Charles R. Mongrain, Deputy I
- c. Patricia A. Clymer, Assistant Clerk I
- d. Gay E. Fazio, Assistant Clerk I

3. The Board of Aldermen hereby resolve to opt out of any early voting and hereby direct the Village Attorney to draft a

letter communicating this desire to the St. Lucie County Supervisor of Elections.
