

RESOLUTION 2023-6

RESOLUTION OF THE TOWN OF ST. LUCIE VILLAGE, FLORIDA, TO APPROVE THE GRANT APPLICATIONS AND AUTHORIZE THE MAYOR OR DESIGNEE TO SUBMIT SUCH APPLICATIONS WITH THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION FOR THE RESILIENCE FLORIDA CAPITAL GRANTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Environmental Protection accepts grant applications each year pursuant to Section 380.093, Florida Statutes for inclusion of projects into the “Statewide Flooding and Sea Level Rise Plan” submitted to the Governor and Legislature for funding; and,

WHEREAS, the program provides funds to local governments to undertake capital resilience projects addressing flood risk; and,

WHEREAS, the Town of St. Lucie Village seeks to apply for **two** capital grant applications for the 2023-2024 grant cycle; and,

WHEREAS, the Board of Aldermen of the Town of St. Lucie Village supports the submittal of applications and authorizes the Mayor or designee to submit the applications to the Department of Environmental Protection.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF ST. LUCIE VILLAGE, FLORIDA, that:

The Board of Aldermen hereby authorizes the Mayor or the Mayor’s designee to submit the following applications for the Florida DEP:

Two grant applications for projects, as follows:

No.	Project Title	Project Description
1	St. Lucie Village Septic to Sewer – Phase 1 Construction	Construction of a pressure sewer system to serve 192 residential properties in areas accessed by Chamberlin Boulevard, St. Lucie Lane, and Milton Road
2	Tide Valves on Stormwater Outfalls	Installation of tide valves on stormwater outfalls to reduce tidal flooding of roads and property

This Resolution shall be effective upon passage.

The forgoing resolution was offered by Jim Grimes, who moved its adoption. The motion was seconded by Dale Reed, and upon being put to vote, the vote was as follows: 5 in favor, and 0 opposed. The Mayor of the Town of St. Lucie Village thereupon declared the resolution was duly passed on 20th of June, 2023.
