

RESOLUTION 2025-3

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF ST. LUCIE VILLAGE, FLORIDA, PERTAINING TO PERMIT AND PLAN REVIEWS FEES, AND INSPECTION FEES, CHARGED AND COLLECTED BY THE TOWN OF ST. LUCIE VILLAGE AND THE BUILDING OFFICIAL OF THE TOWN OF ST. LUCIE VILLAGE, FLORIDA.

WHEREAS, the Town of St. Lucie Village previously adopted schedules for permit and plan review fees in Resolution 2006-7 dated July 18, 2006, which were amended by Resolution 2013-10 dated November 19, 2013, Resolution 2017-5 dated September 19, 2017, and Resolution 2018-1 dated February 20, 2018

WHEREAS, the most recently approved schedules require correction and/or clarification; and

WHEREAS, the Board of Aldermen of the Town of St. Lucie Village desires to adopt the attached corrected and revised fee schedules.

NOW, THEREFORE, be it resolved by the Board of Aldermen of the Town of St. Lucie Village, Florida as follows:

1. That the permit and plan review fees, and the inspection fees, to be charged by the Town of St. Lucie Village and its inspector(s) shall be as set forth in the attached schedules.
2. That no site plan or plat approval, or certificate of occupancy, shall be issued until all applicable fees have been paid.
3. That, to the extent that any prior Resolutions adopted by the Board of Aldermen of the Town of St. Lucie Village, Florida are inconsistent herewith, the provisions hereof shall control.

4. That all prior provisions of Resolutions adopted by the Board of Aldermen of the Town of St. Lucie Village, Florida, which are not inconsistent herewith, shall remain in full force and effect.

5. That this Resolution shall take effect on July 15, 2025.
