

## RESOLUTION 2026-4

**A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF ST. LUCIE VILLAGE, FLORIDA, ESTABLISHING AND IMPEMENTING AN ANNUAL RENEWAL FEE FOR VACATION RENTALS REGISTRATION AS PROVIDED IN ORDINANCE 2023-3, AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Board of Aldermen of the Town of St. Lucie Village, Florida, adopted Ordinance 2023-3 implementing a system of registration for Vacation Rentals, and providing for annual renewals.

WHEREAS, at the time the ordinance was adopted, it provided for an initial registration fee of \$650.00 and for a renewal fee to be charged but did not set the renewal fee amount.

WHEREAS, pursuant to said ordinance, the Board of Aldermen may set and adjust the fee.

WHEREAS, the Board of Aldermen has considered the impacts on the municipality including the time and expense involved in registering and re-registering, as well as regulating, Vacation Rentals, and determined that a significant fee is necessary address the associated expense.

NOW, THEREFORE, the Board of Aldermen of the Town of St. Lucie Village, Florida hereby ordains:

1. The annual renewal fee to be paid in accordance with Ordinance 2023-3 shall be \$325.00; provided, however, that if ownership of the property changes during a given year, the next renewal shall be deemed a new registration and accompanied by the required information of the \$650 registration fee. In accordance with Ordinance 2023-3, these fees are subject to adjustment by further Board resolution

2. This resolution is effective upon passage and shall apply to any re-registration during the current fiscal year and thereafter.
